2. Retention of Members – Permanent Positions

The recruitment and retention of qualified members in today's labor market is difficult and competitive. All neighboring services, including West Grey, Hanover, Owen Sound and the OPP are actively recruiting members of all positions, and we are competing for the very best candidates. We have been very fortunate over the past year to have attracted very qualified candidates as both Special Constable and Support Services members. These members have been hired on fixed-term contracts and have proven to be very valuable to the police service.

3. Special Constable Positions – Convert to Fulltime

As discussed during the 2025 Budget presentation to the Police Service Board, funding to convert both 40-hour a week Special Constable contract positions to fulltime permanent positions was approved. The cost to the Police Service budget includes the cost of benefits and leave allotments.
