- The Crown will afford priority to counsel/agents who send a list of their matters in advance of court. Please send your list, as well as any requests for priority to the Crown <u>and</u> Court Services (<u>Walkerton.OCJ.Courts@ontario.ca</u>) no later than 12:00 p.m. <u>two business days</u> prior to the appearance.
- Please send any enhanced designations to Crown and Court Services within the time frame provided by the Practice Direction.

<u>COURT</u>

- When you attend court using the link provided or by calling in over the phone, you will be placed in a waiting room.
- When your matter is to be addressed, the court clerk will move you from the waiting room into the Virtual Courtroom. You may be on hold for some time.
- If you attend by phone, only your phone number (not your name) will appear in the waiting room.
- When you are in the Virtual Courtroom, place your phone on mute until it is time to address your matter(s).
